EXECUTIVE SUMMARY

1. General Overview of all activities.
1-13 July 1969. The battalion was at VOB preparing for deployment to Okinawa.

- (3) C-130's were provided for lift of the Battalion from Quang Tri to Danang.

9. Communications-Electronics.

- a. General: Normal communications were maintained at VCB from 1-13 July using equipment which was borrowed from 1st Battalion, 4th Marines. All communications equipment which was borrowed from this unit was being made ready for deployment to Okinawa at this time.

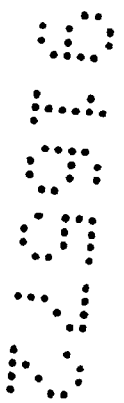
